Phoenix Podiatry Clinic is committed to protecting the privacy of your personal information. This Privacy Policy outlines how we collect, use, disclose, and store your personal and health information in accordance with the Privacy Act 1988 and the Australian Privacy Principles (APPs). It also reflects how Cliniko (the software we use to manage patient records) handles data in compliance with Australian privacy laws.

1. Information We Collect

We collect personal and health information directly from you and indirectly through Cliniko, which stores patient data on our behalf.

- **Personal Information:** Includes your name, contact details (e.g., phone number, email), address, and emergency contact information.
- **Health Information:** Includes medical history, treatment notes, diagnoses, and any other clinical information relevant to your podiatric care.
- Financial Information: Includes payment details, billing information, and insurance
- Browser and Hardware Data: Such as IP addresses, device type, browser type, and other technical information automatically collected when you interact with our systems.

2. How We Collect Information

- **Directly from You:** When you provide us with personal details during consultations, through online forms, or by phone/email.
- **Indirection via Cliniko:** When your healthcare provider records personal or health information about you in **Cliniko**. Cliniko may also collect personal information indirectly on behalf of the clinic, including your treatment history and health records.

3. How We Use Your Information

We use the information we collect to provide podiatry services, manage your appointments, and process payments. Specifically, we use this information for:

- Providing personalized care and treatment.
- Communicating with you regarding your appointments and treatment plans.
- Billing, insurance claims, and payment processing.
- Meeting legal and regulatory obligations.
- We also use **Cliniko** to manage your data securely and efficiently

4. How Information Is Stored and Secured

We store your personal and health information securely in **Cliniko**, which employs robust encryption methods, access control policies, and other security measures. **Cliniko** ensures that the data is stored in state-of-the-art facilities and complies with relevant data protection regulations. In the event of a data breach, we will notify you within 72 hours if your personal information is at risk, providing details on the breach and the steps we have taken to mitigate the risk.

5. Sharing and Disclosure of Information

We may share your information with:

- Other Healthcare Providers: If needed for coordination of care (e.g., specialists, labs).
- Third-Party Services: Such as payment processors, IT providers, and data storage services. These third-party services are bound by confidentiality agreements and are restricted in their use of your data.
- **Legal Requirements:** We may disclose your information if required by law or in response to a subpoena. We will not sell or rent your information to third parties for marketing purposes.

6. Access, Correction, or Deletion of Personal Information
